*A Megan's Law check will be conducted on ALL adults who drive and/or chaperone.

*ALL adults who drive or are in a car with other people's children will be required to provide proof of being fully vaccinated against COVID-19. Everyone in the vehicle must wear masks. Unvaccinated individuals may not drive other people's children.

*Adults who only drive their own children will still be considered chaperones, and will need to either provide proof: of being fully fully vaccinated against COVID-19 or an authorized (not home-kit) negative COVID-19 test taken within 72 hours prior to the trip.

For this trip negative tests will need to be taken after Oct 17th and turned in by Oct 20th.
