1. Opening (Roll Call and Establishment of Quorum)

Meeting called to order at 4:08pm. In attendance were council members: Mrs. Debbie Hobin, Mr. Eric Tam, Mr. Greene, and Ms. Julie Haas-Wajdowicz. Staff members in attendance were: Mr. Kevin Fuller, Mrs. Elisa McCutcheon, and Mrs. Andi Stahler. Also in attendance, Mrs. Kelley Borges and Mrs. Tracey Tim Tim.

- 2. Approval of Minutes
 - a. Regular Charter Council meeting of October 14, 2021

- 3. Oral Communications: Non-agenda items: None
- 4. Comments from Staff

Mr. Fuller addressed the Council on behalf of ACA and stated that ACA is approaching the end of the first trimester. This week is a conference week, with half of the day working with the students and the second half conferencing with families.

Mrs. McCutcheon addressed the Council on behalf of ACA II and stated that they are also having conferences this week with the majority of them on Zoom, while a few requests to be in person conferences were accommodated for. ACA II had their second School Families session, with Middle School stepping up and leading the family groups. Family Network has resumed 2nd Cup of Coffee meetings for parents. Middle School has been working on Social Political Action Projects with one group focusing on Homeless people, and they were able to make 100 bags of toiletries and clothes for the COC, as well as gather lots of blankets, food, and other items to take to the organization. There is an Anti-Bullying group that raised \$287 to donate to *StopOutBullying.org*. The Environmental group has planned Litter Pick Ups around Antioch. Mrs. McCutcheon also shared that she and Edna Heller have been meeting monthly with Andy Cannon from AUSD, which has provided a positive line of communication for both schools and AUSD.

- 5. Discussion Items (for possible Action)
 - a. Educator Effectiveness Grant spending plan

Mr. Fuller addressed the Council and shared that this Grant is intended for professional learning for Teachers and Paraprofessionals that work with pupils. Both campuses qualify

for this Grant as long as we are able to develop and adopt a plan prior to the end of December. We have now through the 2025-2026 school year to utilize these funds. ACA and ACA II plans are attached for further review. Mr. Fuller and Mrs. McCutcheon walked through the plans with Council.

b. AB361 reform – teleconferencing requirements for Charter Council meetings

Mr. Fuller addressed the Council and shared that the primary effect of this reform is to allow public bodies to dispense with certain normally applicable Brown Act teleconferencing requirements wherever a public body holds a meeting during a proclaimed state of emergency. This must be voted on every 30 days by Council.

c. Policy update and review (attached) - Independent Study Policy

Mrs. McCutcheon addressed the Council and shared that any time a student has 15 or more days of absences, cumulatively, through the school year, the state has asked for additional requirements to be met for this policy. The revised policy brought to you today, shows the new policy, with the change being on page 5, in section 16, that if the student does not submit the work assigned within the agreed upon timing, the student will not receive full academic credit, instead of *all* academic credit.

d. Nomination Committee - update regarding open seats on Charter Council

Mr. Fuller addressed the Council and shared that the nomination committee consists of Mr. Heller, Mr. Tam, and Mr. Fuller. They are currently looking for candidates and have reached out to numerous members within the community and school families. So far there have been 6 interested people and two applications submitted. The committee plans to meet after the November break to schedule the interviews with the two current potential candidates.
